The number of arbitrators shall be three. The seat, or legal place, of arbitration shall be DIFC. The language to be used in the arbitration shall be English. The governing law of this arbitration agreement shall be the substantive law of DIFC.
- 15.3 The previous Clause shall not preclude the making of an application to any competent court for injunctive relief.
